What is a Small Developer?

- Generally used to describe projects with <
 5MW capacity i.e. small wind category
 REFIT
- Not necessarily the full story
- Member projects range in size from 250KW to +100MW
- Independent developers

Challenges for Members

- Extraordinary delays in realising projects some almost 10 years due to planning, grid moratorium, stop-go AER / REFIT.
- Long drawn out process means developers are carrying costs for longer than desirable.
- Independent developers with large number of projects are facing difficult choices.
- Grid connection; High up front costs outside project finance.
- Planning still an issue in spite of new guidelines, environmental designations causing havoc with planning applications and renewals

Challenges for Members Contd.

- Access to finance is a general issue although small projects are being banked with higher equity requirements
- Some turbine suppliers are not as cooperative as others on smaller projects, thankfully we have very solid relationship with a particular turbine supplier
- Irish Bank costs extremely high
- Irish legal and engineering costs are high
- Need to develop new financial models with European banks and investors

Big Issues

- Uncertainty about future market for energy in Ireland due to economic downturn
- Question mark over future of REFIT due to U turn on additional categories i.e. offshore, wave and biomass.
- We need feed in tariffs and costs similar to other countries
- Full economic impact of constraining is an unknown
- Planning issues and huge delays likely with grid connections
- Need an NRA approach to grid development
- Planning extensions for wind farms needed now.

Where to for the Small Developer?

- Future is as good it ever was in spite of the challenges
- Niche projects on good sites will succeed
- Higher costs must be tackled esp. Grid
- New financial models being created
- Very determined and driven sector

Outlook

- Positive
- Role of local and community developments must be formally recognised in grid process and REFIT
- Interconnection
- Electricity for transport
- Development of energy storage
